

**WEBB CARPET COMPANY
INSTALLATION HELPS AND RESPONSIBILITIES**

1. HOMEOWNERS ARE ASKED TO REMAIN OUT OF THE WORK AREA FOR SAFETY REASONS. WE ALSO ASK THAT YOU PLEASE SECURE ALL PETS OUT OF THE WORK AREA.
2. INSTALLATION INVOLVES MOVING FURNITURE AND LARGE ROLLS OF PAD OR MATERIALS, THEREFORE **EXPECT SOME MARKS** ETC. ON WALLS AND POSSIBLE MINUTE SCRATCHES ON BASE BOARDS.
3. REMOVE ALL SMALL ITEMS & VALUABLES FROM WORK AREA (PICTURES, LAMPS, SHOES, ETC) & REMOVE BEDDING SHEETS IF APPLICABLE.
4. HOMEOWNER IS RESPONSIBLE FOR MOVING ALL ELECTRONICS. IF UNABLE TO MOVE SUCH OBJECTS, THE INSTALLER CANNOT BE HELD RESPONSIBLE FOR DAMAGE ASSIST.
5. WEBB CARPET PROVIDES INSTALLATION WARRANTIES FOR ALL OWNER OCCUPIED PROPERTY FOR 2 YEARS. FLOOR MOVEMENT ISSUES ARE NOT WARRANTED.
6. WE DO NOT MOVE : FISH TANKS, GERMAN SHRUNKS, GRANDFATHER CLOCKS, OR POOL TABLES. SOME ITEMS SUCH AS PIANOS MAY REQUIRE PROFESSIONAL MOVERS. IF YOU HAVE SUCH ITEMS DISCUSS WITH SALES PERSON.
7. NOT ALL SQUEAKS CAN BE REMOVED FROM SUB-FLOORS THEREFORE WE CANNOT WARRANT SUCH REMOVAL, IF YOU KNOW OF ANY PLEASE INFORM US.
8. DUST IS A NATURAL PART OF INSTALLATION (ESPECIALLY WOOD PRODUCTS) HOMEOWNER OR BUILDING CONTRACTOR SHOULD COVER OPENINGS TO HELP CONTAIN DUST. IF NECESSARY TURN HEAT OR COOLING UNIT OFF TO PREVENT SPREAD OF DUST.
9. **IF UNIT IS UNOCCUPIED OR HOMEOWNER IS NOT PRESENT THE WATER CONNECTIONS FOR WASHER & REFRIDGERATOR ICE MAKER WILL BE LEFT OFF AND OTHER PARTIES WILL BE REQUIRED TO TURN ON .**
10. **VERY IMPORTANT- BEFORE INSTALLER LEAVES CHECK ALL CONNECTIONS FOR WATER LEAKS & APPLIANCES FOR OPERATION . CHECK DAILY FOR AT LEAST A WEEK TO ASSURE NO SIGNS OF WATER OR LEAKS. IF NEW CONNECTIONS OR HOSES ARE REQUIRED IT IS THE OWNERS RESPONSIBILITY TO FURNISH SUCH.**

HOT WATER HEATER AND DISHWASHER REMOVAL IS TO BE DONE BY PLUMBERS .

11. DOOR JAMS MUST BE CUT FOR HARD SURFACE PRODUCTS. WEBB IS NOT RESPONSIBLE FOR CUTTING HIDDEN WIRES.
12. HOMEOWNER'S RESPONSIBLE FOR FINAL CLEANING: ASK FOR DETAILS.
13. **ALL SPECIAL ORDER MATERIALS ARE SUBJECT TO MANUFACTURER'S RE-STOCKING FEES AND TIME LIMITS FOR RETURNS ARE APPLICABLE.**
14. **PLEASE INSPECT WORK BEFORE INSTALLER LEAVES AND SIGN THE INSTALLATION WORK ORDER TO VERIFY WORK IS COMPLETED.**
